INCLUDED ITEMS

TRANSPORTATIONS & EXCURSIONS Daily excursion transportation and admissions are **included**.

CARE Check-in is 7:30 – 9:30 a.m. and Pickup is 4:00 – 5:30 p.m. Supervised care by our attentive staff is included for up to 10 hours daily. Early Pickup can be coordinated at the excursion location, if needed.

DAILY SNACK A daily snack and water are provided throughout the day. Additional snacks may be purchased.

ITEMS NOT INCLUDED

LUNCH We encourage campers to bring a sack lunch from home. A catered option is available for \$5.00/lunch and can be purchased each day. Options rotate between Chick-fil-a, Domino's Pizza, Lawler's BBQ, and Subway.

ADDITIONAL SNACKS A pre-paid snack "charge account" can be set up at anytime.

LATE PICK-UP Pick up after 5:30 p.m. is "late." A fee of \$3/minute applies per child after 5:30 p.m.



TERMS AND CONDITIONS Please Read and Initial Each Item.

I understand that registration and deposits are non-refundable and secure my child's place in my selected sessions.

Should a transfer of a session be necessary, I agree to do so prior to 7 days of the start of the camp session. I understand I will not receive a credit or refund for sessions that are within 7 days of starting.

I understand that by enrolling my child into the UAC Adventure Seeker Day Camp Program, that I am committing myself to paying the balance for all selected camp sessions should my child attend or not. Refunds, credits or transfers will not be given for missed days for any reason.

In the event of default of payment, such as returned checks, a fee of \$25 applies and a \$5/day fee will be assessed for each day past due. If account falls past due in excess of 10 days, in addition to the outstanding balance and assessed fees, a reasonable attorney's fee, all court costs, and the expense of litigation incurred in enforcing the terms of this contract will be my responsibility.

Payments can be made by cash, check, or credit card. If necessary due to account history, my account may be placed on a pre-paid cash status.

UAC will not be responsible or liable for the payment of any medical treatment for injuries that are the result of normal supervised play and activities. Parental insurance is considered primary.

All written rules and verbal instructions are to be followed for the safety, enjoyment, and efficiency of all campers. Three documented warnings may constitute immediate dismissal without refund.

My child(ren) may be photographed during daily activities that would present the UAC Adventure Seeker Program and its participants in a positive manner. These photos may be used in media publications.

If my child(ren) require(s) medication, I will provide the necessary medication in a clearly labeled ziplock bag with written instructions on the "Medication Authorization Form." This includes sunscreen.

I give permission for my child(ren) to engage in indoor and outdoor summer activities including, but not limited to, summer cinema, hiking, kickball, basketball, horseback riding, low-level zip lining, petting zoos, swimming, waterslides, playground equipment, roller skating, laser tag, and inflatable use.

UAC is not responsible for possessions or electronic devices I allow my child to bring to camp.

I understand that I will receive an itinerary for the week upon check-in of the first day of each camp session and that activities may change due to weather, safety, or other unforeseen circumstances.

I agree to have my child(ren) signed in by 9:30 a.m. and understand that excursion departure takes place between 9:30 – 10:00 a.m. If my child misses departure, it is my responsibility to make arrangements for my child to join UAC at the location of the excursion. No adjustments will be made for missed activities.

I agree to pick up my child(ren) by 5:30 p.m. daily or pay the required "late" pickup cost of \$3/min. Mandatory DHR Clause: THE DEPARTMENT OF HUMAN RESOURCES DOES NOT INSPECT AWAY-FROM-CENTER ACTIVITIES, INCLUDING SWIMMING OR TRANSPORTATION OR ANY OTHER ACTIVITIES. THE LICENSEE ASSUMES FULL AUTHORITY AND RESPONSIBILITY FOR ACTIVITIES AWAY FROM THE CENTER.
